### Greetings Brethren:

Welcome: Welcome to the Hill City 456 January 2013 newsletter. I hope you each had the opportunity to spend time with loved ones over the past holidays. With our compressed and busy schedule in December, I did not get a December issue published. This newsletter should get us back on track and communicating with our membership and Masonic community. This newsletter will cover some important events from December and look forward into the next several months at Hill City 456. I thank you for your readership of our newsletter.

Goodbye 2012: We began December with our Stated Meeting and Grand Lodge the following week. At our December meeting we earmarked our charitable donations to a couple of our Masonic Charities. Through the beneficence of our members of years past we are able to annually contribute at Grand Lodge to Masonic organizations such as the Texas Masonic Retirement Center. This recipient is important to me for reasons I would happily discuss with any of you in person. Briefly, here are some admissions criteria:

#### TEXAS MASONIC RETIREMENT CENTER

Texas Master Masons, who have continuously been in good standing in a Texas Lodge working under the jurisdiction of the Grand Lodge of Texas or a Texas Chapter working under the jurisdiction of the Grand Royal Arch Chapter of Texas for five (5) years preceding the application, are eligible to move into the TMRC.

Requirements for Family Members of Eligible Masons:

- Widows
- Wives
- Mothers
- Never-married daughters
- Never-married sisters

Wives, widows, divorced or widowed mothers, never-married sisters, and never-married daughters are eligible if the related eligible Texas Master Mason is(was) in good standing with their Texas Lodge or Chapter. When the wife or widow of a Master Mason applies for admission, she must have been continuously married to the eligible Mason for three (3) years prior to the time of application.

It gives me great personal satisfaction that Hill City 456 has the ability to annually support the Texas Masonic Retirement Center. This is one of the ways that Masonry can affect lives. #### **GRAND LODGE ANNUAL MEETING**

The second week of December, your elected officers were in attendance at the Lodge Texas Grand of communication and business meeting. Go to your local County Tax Assessor's office and make your purchase there. If they are not aware of the availability of the Texas Mason plates, have them check online (their screen is different from your computer). The TEXAS MASONS plates were not posted until early on the morning of June 1, 2011. Your County Tax Assessor would not have known about them prior to June 1 and may mistakenly send you to MyPlates. The TEXAS MASONS plates are NOT available through MyPlates.

Our plates are listed with the TxDMV as TEXAS MASONS and that is how to ask for them not (Masonic plates, etc.). There may be problems finding the application form, however, the generic form VTR-999 is being used successfully.
