Grand Master's Message (continued)

As Texas Masons continue to live through the challenges of the existing global COVID-19 with governmental "shelter-in-place" orders and no stated or called meetings of their Lodges, I encourage all Masons to communicate, as permitted, with other Masons. This can be done by telephone, or the on-line platforms. I also encourage all Texas Lodge officers to regularly meet in the above manner to review and authorize the payment of necessary Lodge expenses that cannot be deferred until traditional meetings are again permitted.

It is also possible that Lodge members may request financial assistance from the Grand Lodge Assistance Fund covered in Art. 123 of our statutes. The Lodge of the applying Mason should prepare and submit the appropriate application to the Grand Secretary's office with information provided by the member. The application form can be obtained by the lodge secretary through the Secretary portal. If applications for assistance are received, the five principal Lodge officers are to meet in the above manner and get approval of the DDGM who will forward the application to the Grand Secretary's Office.

Many questions have been asked as to whether and/or how the election and installation of Lodge officers will take place. Your Grand Lodge Trustees are well aware of the need to hold elections and install officers as our Laws require. Be assured that the Grand Lodge Trustees have contingency plans to provide for elections and installations if the meetings restrictions imposed by this crisis do not lift before June. However, it is premature to implement those plans at this time. We are praying that the threat will be abated by June so that Lodges may hold their elections and installation in a timely fashion. If so, there should be no problem in carrying on this business in the normal and usual manner. However, if the pandemic has not evolved such that traditional meetings can resume, the Grand Lodge Trustees will advise you on the alternative methods we will use in our elections and installations.

Please be assured that I am in almost daily communications with the officers of your Grand Lodge, the Masonic Jurisprudence and Civil Law Committees, and our other resources. I also realize several Texas Lodges meet quarterly and that the restrictions of the pandemic may disrupt their

elections. When the Grand Lodge Trustees determine when elections can be held, an appropriate Order or Dispensation authorizing the elections and installations will be issued to all Texas Lodges.

Grand Master's Decision 2020 No. 1

QUESTION: Does the Grand Master have authority to indefinitely suspend stated and called meetings of the Lodge?

ANSWER: Yes, if a local, state, national, or world crisis exists that would warrant such action. This would include pandemics or other crises that result in national, state and/or local orders directing or requiring such suspension of such meetings. Although, at present, there is no specific authority in our Grand Lodge law authorizing such action, nevertheless, the Grand Master has the power and duty to superintend and direct Masonic activities and to ensure compliance with all national, state or local orders directly pertaining to the operations of the Craft.

Grand Master's Decision 2020 No. 2

QUESTION: May the esoteric work of Masonry be studied by telephone between two brothers known to each other?

ANSWER: Yes. The two brothers must know each other as Masons and must assure each other, as far as practical, that the telephonic "voice-only" conversation is secure and is between those two brothers only. No other electronic or digital video or audio platform, service or device is permitted.

From the South

What political party had the first national nominating convention and offered the first platform of party principles? It was the third political party organized in the United States. It was the Anti-Masonic Party.

The movement that brought this political party into existence started in 1826. It was caused by the mysterious disappearance of William Morgan. He was a Freemason and a bricklayer who lived in New York state. He apparently became angry with his Lodge and said he would publish all the secrets of Freemasonry. He disappeared . Some rumors were that he had been killed by Masons. There was also a rumor that he had been told to go to Canada and not return. In any case he disappeared. This was at a time of the Western movement of settlers, the Industrial Revolution and the great religious revival known as the Great Awakening. Many people were distrustful of the government and any long-standing institution. Distrust of the Freemasons began to grow and local politicians got elected by being against masonry. This movement caused the creation of the new party. At this time Andrew Jackson was a prominent Freemason who often spoke about the fraternity. The Anti Jacksonians needed a party to rally around. So the new party was as much about defeating Jackson as it was anti Masonry.

In September 1831 The Anti-masonic Party had a National Convention in Baltimore Maryland and nominated William Wirt for president and created a party platform condemning Freemasonry for its secrecy, exclusivity and undemocratic character.

In the 1832 election Mr. Wirt won the state of Vermont only. He had a total of 7 electoral votes. After this the party went into decline. Much of the political energy was going into the anti-slavery movement. Many members of the Anti Masonic Party moved over to the newly-formed Whig party. The party never nominated anyone else and faded away after about 10 years of existence.

Masonic Education

The Larger Charge

At several times, in building his Masonic edifice, a Mason is given a *charge* in which the values and principles that define being a Mason are expressed in rather succinct instructions. The first, and possibly simplest, charge is given after the conferring Master of the Lodge has asked the Supreme Architect of the Universe for the blessings and "competency" that will enable the new Mason to live up to these subsequent charges, and he has successfully completed the "forms and ceremonies". He is simply instructed "ever to walk and act as such" only to begin a lifetime of figuring out what that really means. After that, each degree ceremony is completed by a longer, more comprehensive charge, and the Mason experiences additional charges in being installed as a Lodge Officer and on other occasions. We said earlier that these charges are succinct instructions and it is true that they sound that way. But is that really all?

We very often talk about symbols and symbolic learning in Masonry, in which an iconic symbol, word or phrase represents not just a small denotative meaning but a connection to a much larger body of thought or knowledge. That symbolic knowledge is synthesized from all we read and experience in Masonry, especially through discussion and sharing among our Brethren. It grows over years and decades and we understand that our enrichment through symbolic learning never really ends. Why should this idea not apply to each and every one of the charges placed upon us?

If the charges were just those words and instructions, could a Mason "check the box" indicating that he had fulfilled one of these charges or even a part of one? Or, just as we spend a lifetime building our Masonic edifice, do we continue to define, refine and expand that sense of what we must do, going forward, to best exemplify the Masonic ideal. Surely it is a personal matter, just as each Mason has his individual understanding of the vast subject of Masonry and his own blessings and cable tow. But this Mason does believe that we all should strive to move forward and grow, not satisfied with the degrees we have, the esoteric work we can recite, the history of Masons we understand, or any aspect of past Masonic service, projects and accomplishments. And, perhaps it is necessary that we extend our sense of Masonic charges, in their symbolic forms, to the greater world around us.
